

The Meeting of the Committee was held on 07.01.2010 at 11.00 a.m.. The following were present :




After considering the rates and other terms and conditions prevalent in this Library, and rates and other terms and conditions prevalent in CCSHAU, GJUS&T, KUK, NIT and DULS, the Committee recommends the following terms and conditions for the purchase of books and other reading material (excluding journals) to the University Library :


1. Discount structure.

Category of document	Discount	Foreign Exchange rates
All Indian and foreign books in all languages including reprints of old books.	25%	Bank Exchange Rates on the date of billing. The exchange rates may be verified from such sources as proof produced by the supplier from their Banker/ Exchange Rates of any Scheduled Bank published in the Economic Times/ Financial Express/ Hindu/ Hindustan Times/ Times of India/ Tribune/ Indian Express
All Indian and foreign books in Sciences, Engg. & Technology and Medicine published more than four years back.	30%	
All Indian and foreign books declared as remainders	50%	
All short/no discount titles/govt. publications/ publications of international organisations such as Unesco, World Bank, IMF, etc./ University publications/ Society and Association publications etc.	Cost of book (-) discount earned + 10% to cover margin of profit and other expenses such as postage, freight etc. Books on which the suppliers get 30% or less discount will be covered under this Clause. The supplier shall produce the proof of price paid and discount earned in the form of Publisher/ Distributor invoice.	
CDs/e-books	20% or the discount structure applicable to short/no discount titles/govt. publications/ publications etc. CDs on which the suppliers get 30% or less discount will be covered under this Clause.	


2. Damaged or defective copies shall not be accepted, and shall be returned at the cost of the Supplier






3. The Supplier shall supply the ordered books within one month from the date of order. In case the supply is likely to be delayed due to some reasons such as procurement of books from abroad, the Supplier shall inform the University Librarian/ his Rep. looking after the Acquisition Section accordingly, indicating the reasons for delay and approx. time required for the supply, and obtain approval thereof.
4. The University Librarian/Manager, MDU Bookshop may cancel/accept the order or take such other action as may be deemed proper by him in the interest of the University, if the order is not executed within the specified period.
5. The Invoice shall be accompanied by the following certificates :
 - i. "Latest publishers' prices have been charged"
 - ii. "The book (s) is/are not remainder (s)"
 - iii. The book (s) is/are short discount or no discount title (s)
6. The lowest priced/paperback/Indian editions shall be supplied, if such editions are available, unless specified otherwise.
7. The consignment shall be FOR, Vivekananda Library, M.D. University Library Rohtak
8. In case of foreign publications, price (s) in the currency of the country of publication along with price (s) in Indian currency and foreign exchange rates shall be clearly mentioned in the Invoice.
9. The date of billing shall determine the rate of exchange of foreign currency.
10. Latest edition/latest re-print shall be supplied.
11. Any discrepancy such as charging of higher price, supply of old edition, supply of foreign edition in place of cheap edition, etc. detected at a later stage, shall be compensated by the Supplier.
12. The country of origin/policy of the Publisher shall decide the currency in which the prices will be charged.
13. Books supplied by V.P.P. without prior permission shall not be accepted.
14. Dispute, if any, shall be subject to the Jurisdiction of Courts at Rohtak, irrespective of what is mentioned in the suppliers' invoice etc..
